Chairwoman Pro-Tem Talley announced that on July 29, 2020, Governor Whitmer passed an executive order limiting public indoor gatherings to ten people. Since there are eight elected officials in the Council Chambers this evening, two persons from the public may enter at a time. Also, face coverings are not required when persons speak at the meeting - including Council members as long as they abide by the social distancing of six feet. Ms. Talley announced that Romulus has surpassed the 70 percent mark for census replies.
