Enclosed for your review is the Fiscal Year 2023/2024 Preliminary Budget prepared for the City of Romulus.

As a reminder, the Council budget study sessions are scheduled for April 3, 2023 and April 10, 2023 from 6:00 p.m. - 7:15 p.m. On April 3, 2023, Patty Braden the Romulus Library Director, will be presenting the Library's portion of the budget. Also included is the FY23/24 Preliminary budget that was provided by the 34th District Court. City Department Heads will be present on the April 10, 2023 study session to answer questions relative to their respective budgets and/or department operations.

The public hearing is scheduled for May1, 2023 at 6:30 p.m. with official adoption and tax levy authorization on May 8th, 2023 at the regular Council meeting. The FY23/24 Budget becomes effective July 1, 2023.
