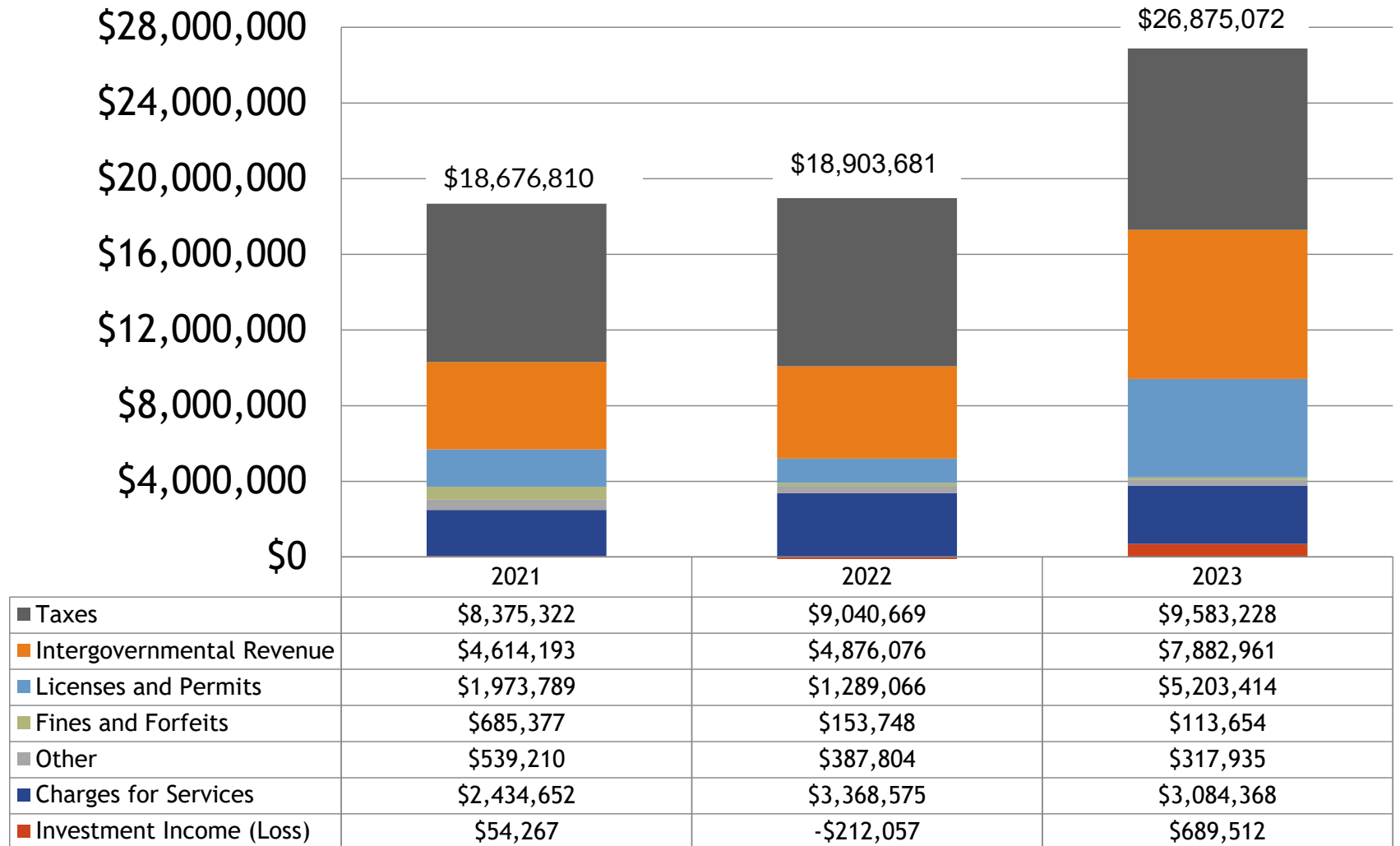

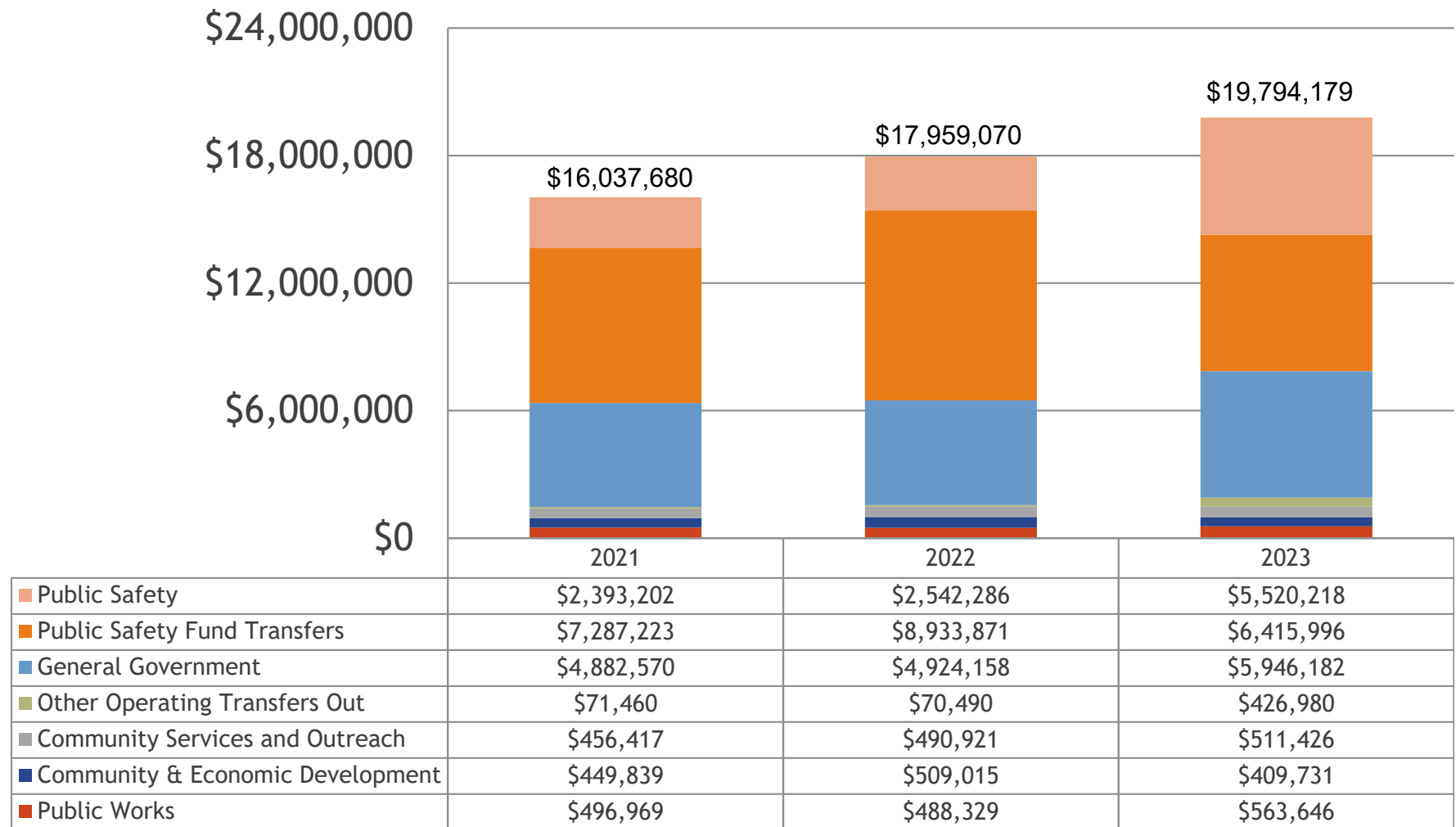


City of Romulus General Fund Revenue and Transfers Years Ended June 30





City of Romulus General Fund Expenditures and Transfers Years Ended June 30

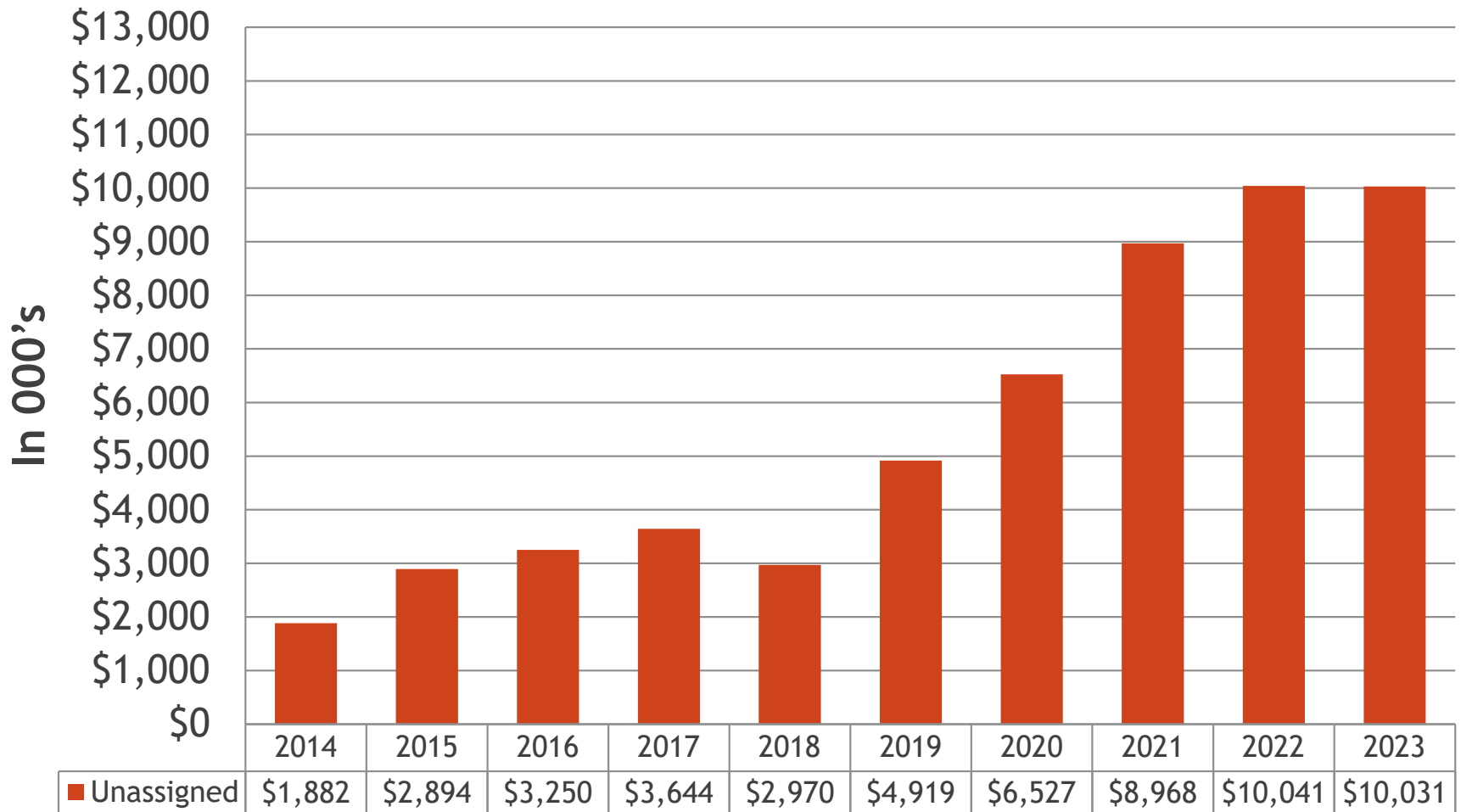

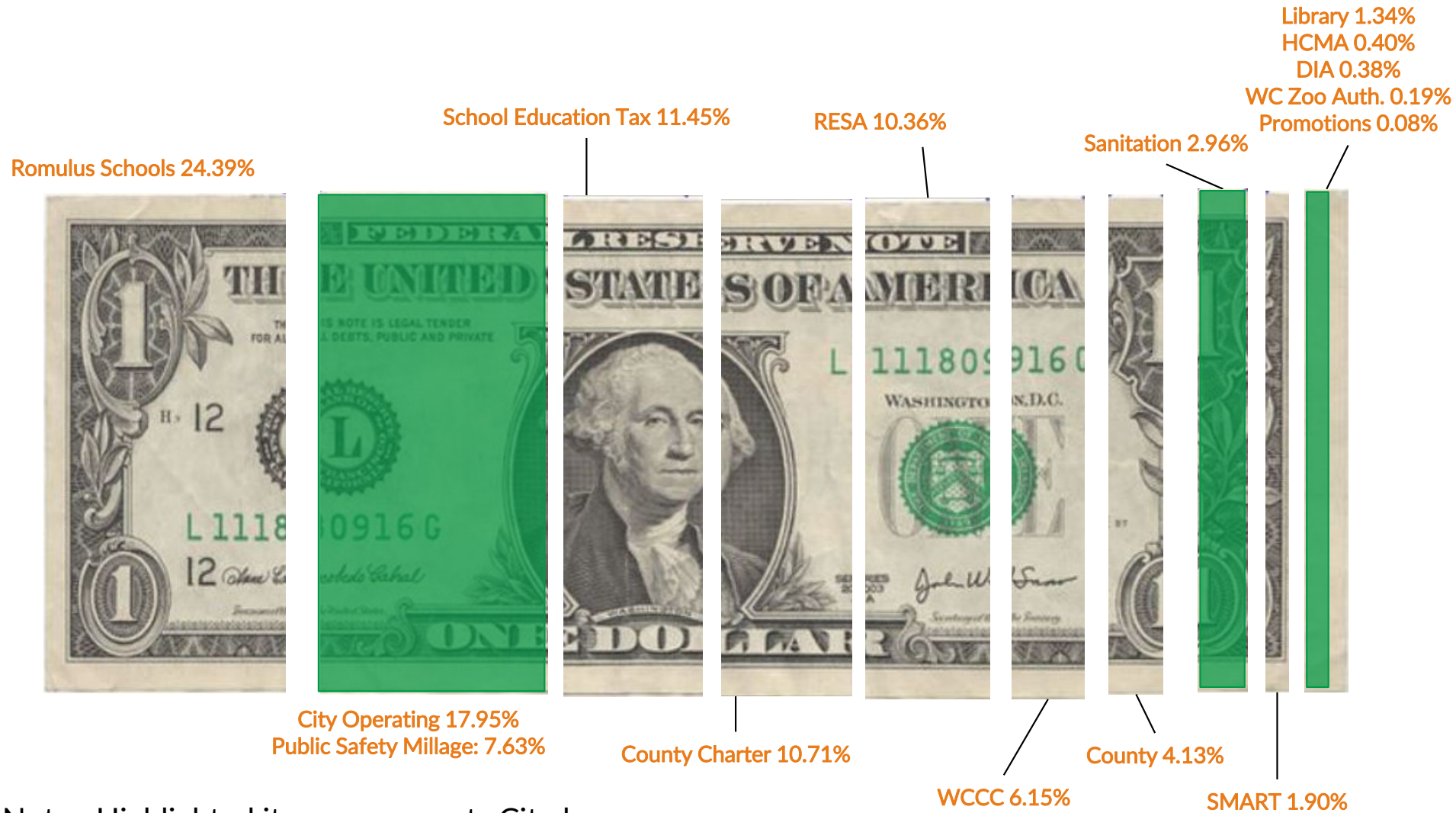
General Fund – Unassigned Fund Balance

Years Ended June 30





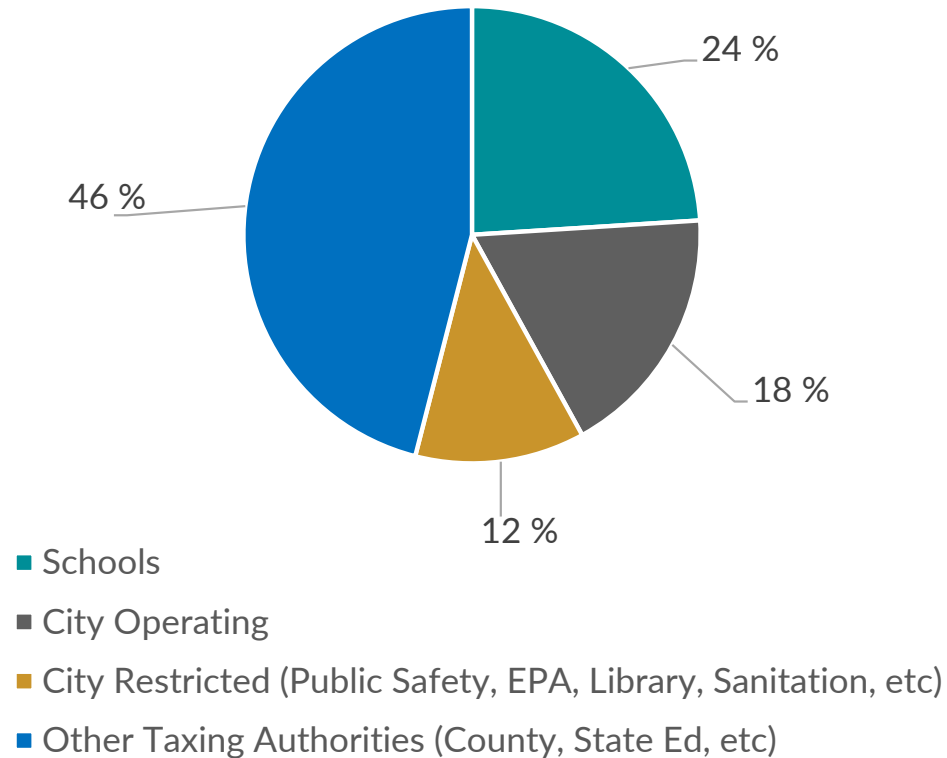
City of Romulus Property Tax Distribution for Dollar Collected





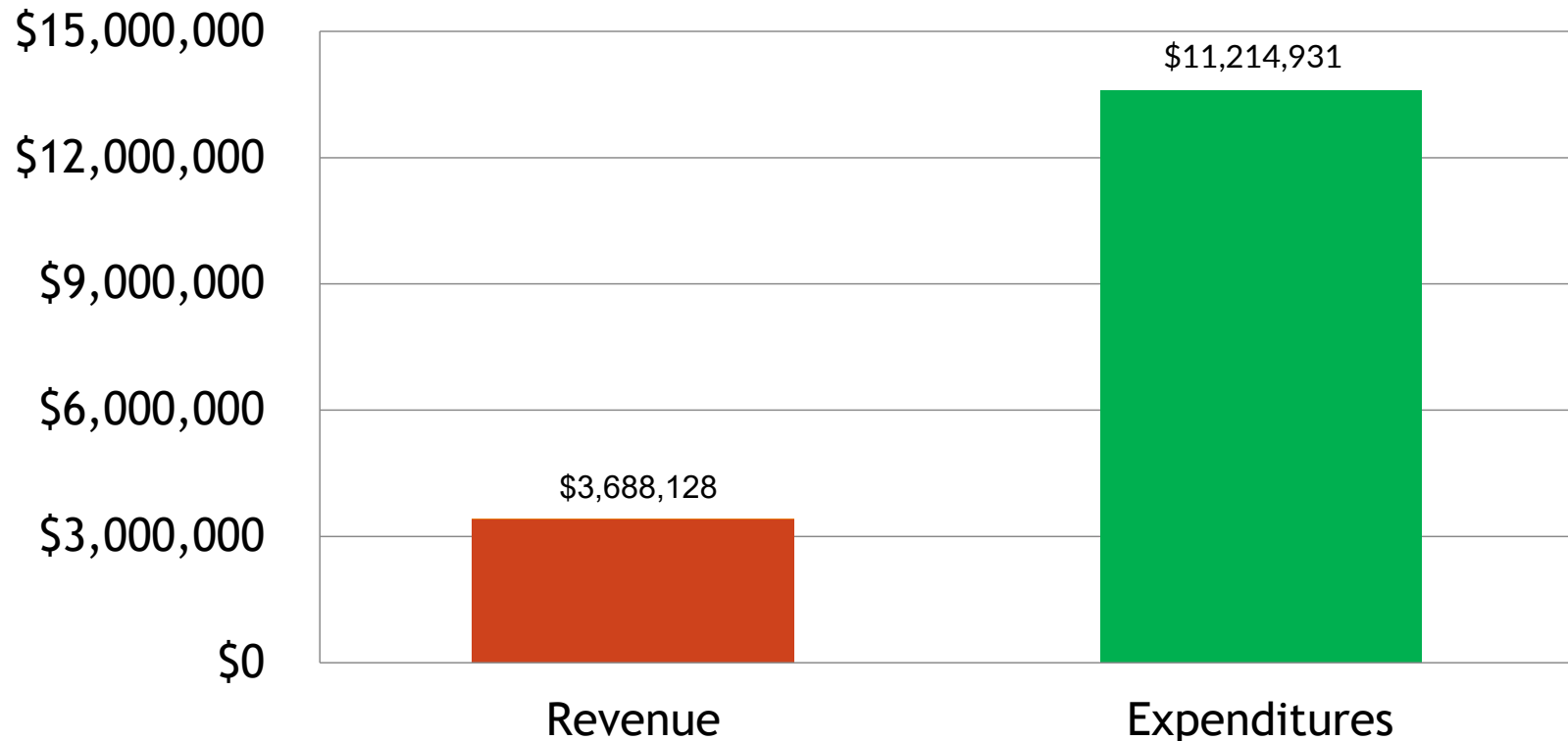
City of Romulus Property Tax Collection Allocation

City of Romulus Public Safety Fund Property Tax Revenue and Expenditures Year Ended June 30, 2023

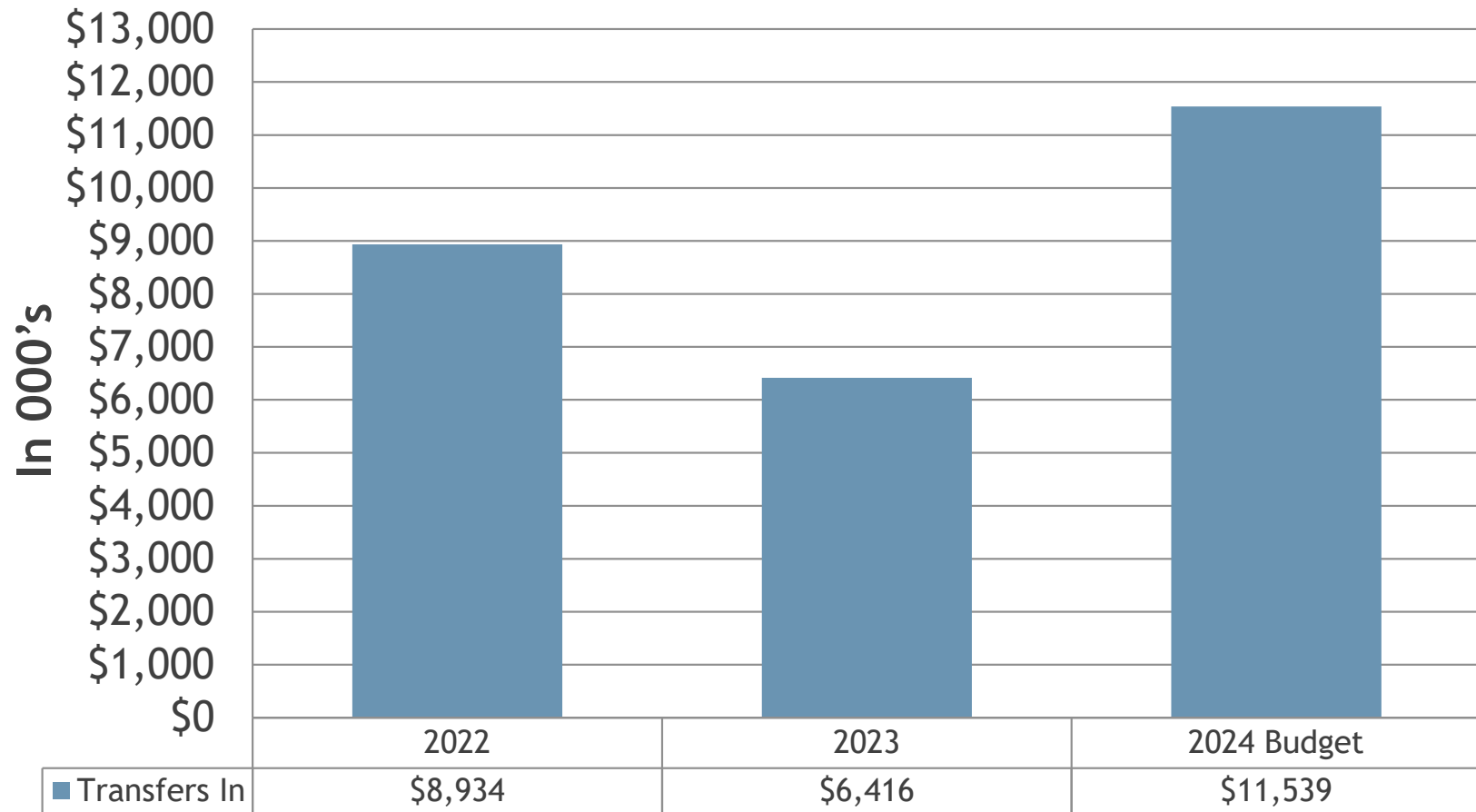


Note: The General Fund transferred \$6,415,996 to the Public Safety Fund to cover public safety expenditures not funded through the millage for the year ended June 30, 2023.

Of the \$11.2 million expenditures noted above, the police department represents \$7.3 million and the fire department represents \$3.9 million.



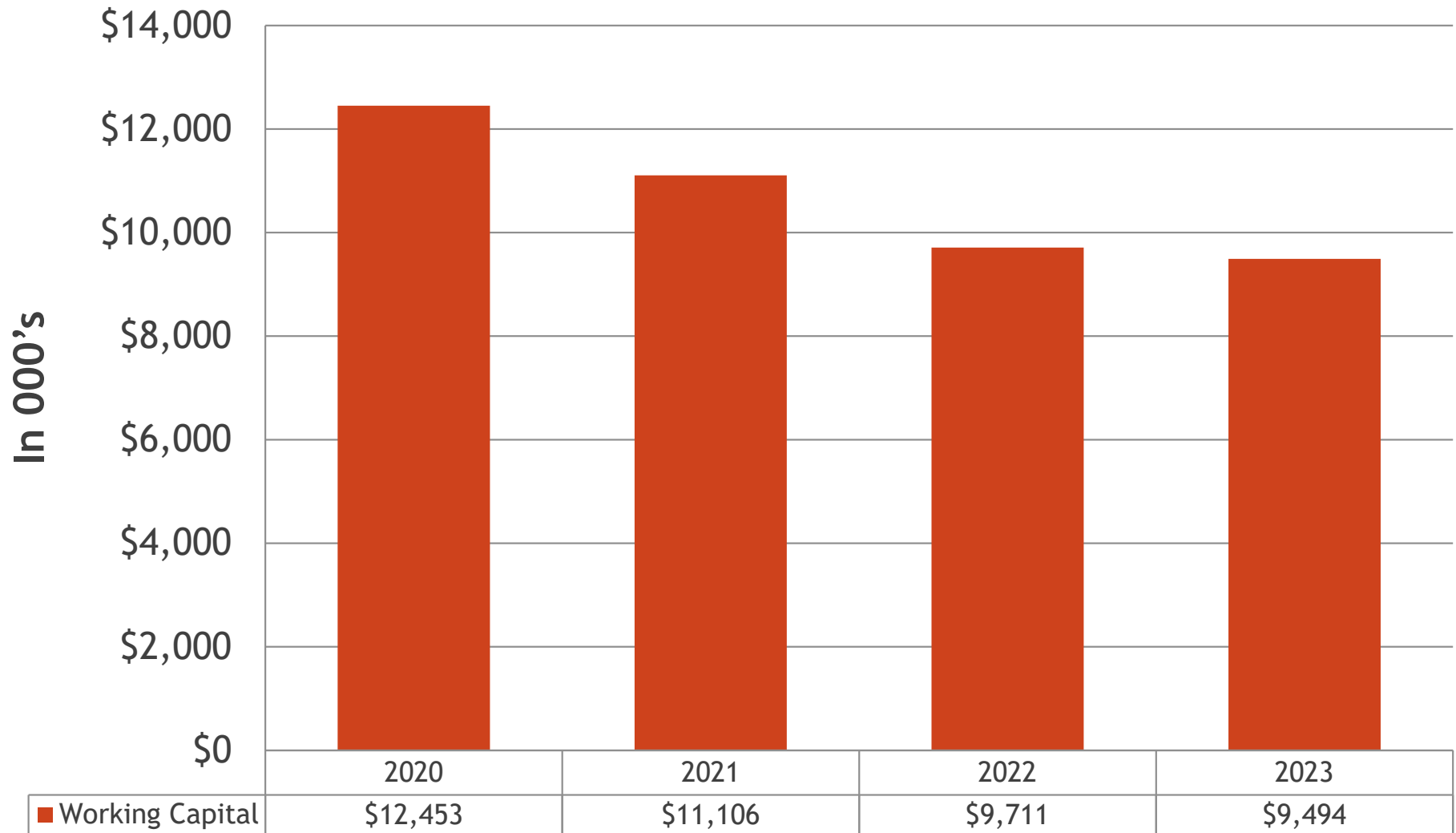
Public Safety Fund Transfer From General Fund



Note: The Transfers in amount for 2023 does not include the \$2,477,256 of public safety wages that were paid by the ARPA fund which is rolled up into the General Fund.

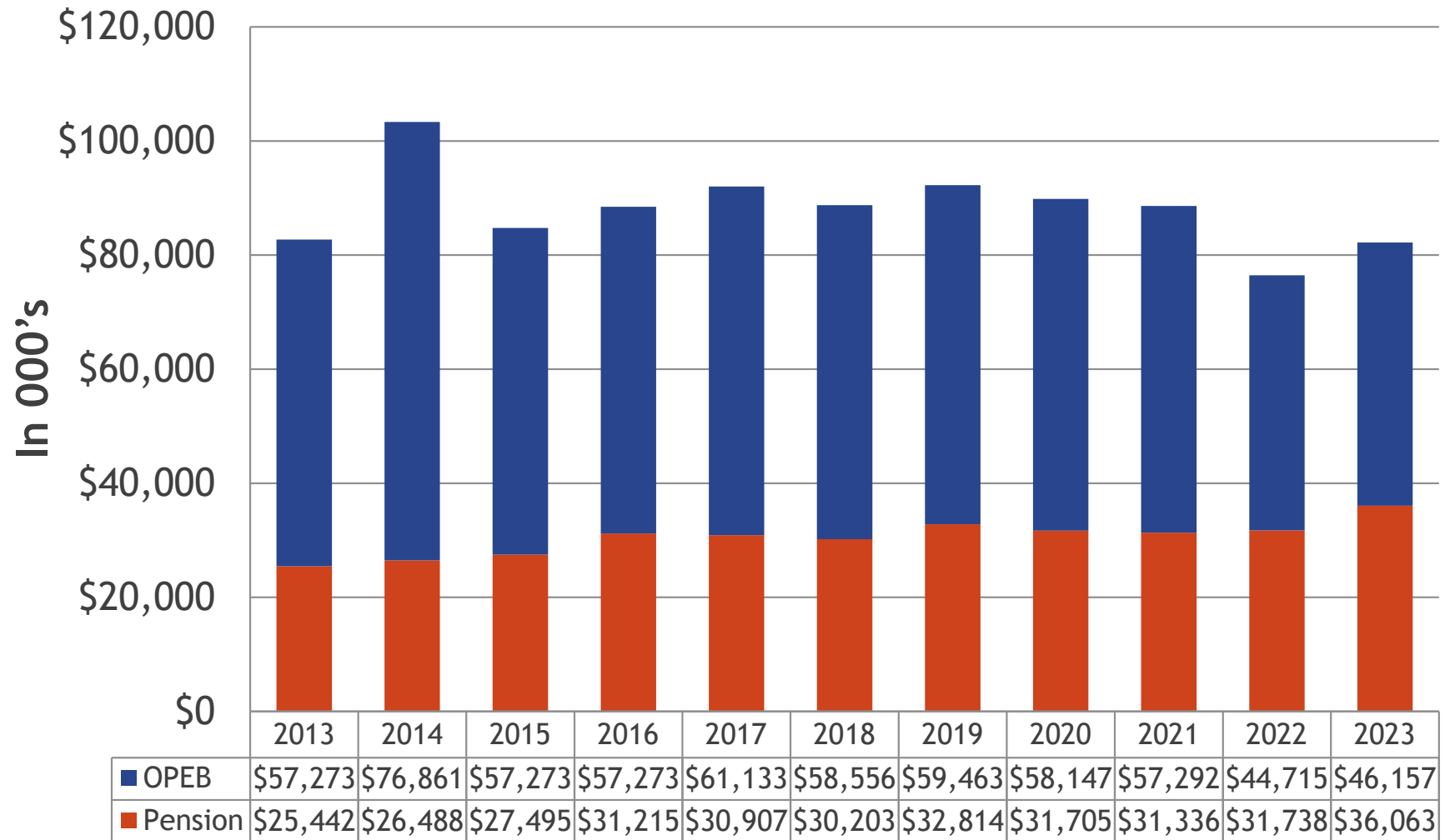


City of Romulus Water & Sewer System Years Ended June 30
