BACKGROUND:

At the March 22, 2021, Regular City Council Meeting, the Council adopted the Honorary Street Sign Dedication Policy that enables the city to commemorate individuals who have made significant contributions to the community and humanity.

DEPARTMENT REVIEW:

Office of the City Clerk

- Out of the eleven (11) applications received, eight (8) of the honorees are deceased.
 - Voter registration files are purged upon the death of the voter; therefore, the City Clerk's Office is unable to confirm voter registration and/or residency.
 - The remaining applications have met residency and voter registration criteria of the program.

Police Department

- A records clearance check returned with NO records of arrest, conviction or sentence to imprisonment for the honorees
 - Requested confirmation of the correct spelling of honoree, Celester Warren, name. A record check identifies the spelling to be Cealistes Warren with the same DOB as honoree; however the search returned with NO records of arrest, conviction or sentence to imprisonment for the above name.

- No objections to the proposed locations of the honorary street signs as indicated on each application.

CONCLUSION:

Per the Honorary Street Sign Dedication Policy, “the City Council shall consider the honorary street naming dedication at a Council meeting. A decision to adopt an honorary street name based on the criteria...shall be effectuated through the adoption of a resolution.”

A copy of the policy has been included in this packet.

At the June 10th Regular City Council Meeting, a request will be made for Council to adopt a resolution approving the honorary street names for the five (5) applicants of your choosing, or alternatively, amend the Honorary Street Sign Dedication Policy to allow for the approval of more than five (5) applications submitted for 2024.



Honorary Street Naming Dedication Policy

The honorary street sign dedication program enables the city to commemorate individuals who have made significant contributions to the community and humanity. These memorials celebrate citizens without imposing substantial burdens associated with modification to the Official Street Map of the City. These honorary street names are meant to commemorate the honoree and do not replace the official street name or require re-addressing of the street.

Restrictions

The potential honoree must:

1. Have made a demonstrable and significant positive impact on the community or contributed to the cultural, economic, educational, intellectual, political, or scientific vitality of the community or have made an extraordinary contribution in the service of humanity;
2. Must be an individual; and
3. Must have resided in the City for at least 35 years and reside in the City at the time of application.
4. Must be a registered voter in Romulus.

The City council shall consider the honorary street naming dedication at a Council meeting. A decision to adopt an honorary street name based on the criteria in this section shall be effectuated through adoption of a resolution. The honorary name shall be for a period of 12 months and may not be renewed for subsequent years. The City will seek approval from the County for all recipients who reside on a County Road.

All applications will be available at City Hall and on the City Website from the first Monday in April and due no later than 4pm on the first Monday of May. All applications must be placed on an agenda for consideration by the third City Council meeting held in June by the Clerk's Office. A maximum of 5 applications will be approved annually. All approved signs will be installed by the Department of Public works no later than last full business week of July and taken down no later than the last full business day of July the following year.

All signs must be picked up by the applicant by the last business day of the first week in August at the Romulus Department of Public works located at 12600 Wayne Rd. between the hours of 8 a.m. – 4 p.m. Monday through Friday.

The City of Romulus will seek donations from individuals, corporations and foundations for the costs but if funds are not available, applicants are responsible for all costs associated with the fabrication, installation, and maintenance of honorary street dedication signs, to be paid upon approval of the

application by Council at the City Treasurer's Office. Only upon receipt of costs in full will the signage be created and installed by the Department of Public Works.

Following removal of the sign the City will also maintain a plaque in the public area of City Hall that will list all recipients of the Honorary Street Name Dedications. Honorary plaques will be updated annually in the calendar year the honorary sign is removed in the first week of August.

Fees

In addition to the cost of the sign, there is a non-refundable \$25.00 application fee. Applicants must complete an application form provided by the City and pay the filing fee upon filing the application made payable to the City of Romulus.

Eddie Jones helped clean up his neighborhood by keeping the Jones Subdivision trash and drug free. Any suspicious activity that he saw, he would report it and have them removed immediately. Eddie was big on having a drug free environment. In the 80/90s he would have all his neighborhood friends children assist him in cleaning up around the neighborhood and he would compensate them with either money or ice cream. The kids of the Jones Subdivision really respect him to this day.

Over the years, Eddie Jones would extend his services of helping the community cut their grass and turn over their soil for gardens with his tractor. He would help those from the middle age to the elderly and small independent companies. He was always there in the help of need whenever he was called. Also, over the past 40 plus years of living at his address, he had large family reunions where he would invite the homeless off the street to come and partake in food and fun recreational activities to make their day. He was widely respected across the Jones Sub community and Romulus overall.

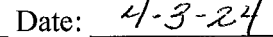

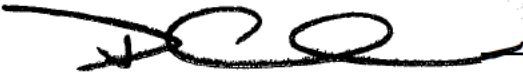

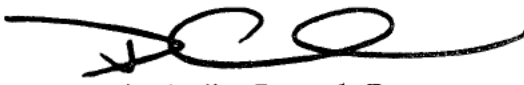
