Enclosed for your review is the Fiscal Year 2025/2026 Preliminary Budget prepared for the City of Romulus.

As a reminder, the Council budget study sessions are scheduled for April 14, 2025, and April 28, 2025, from 6:00 p.m. - 7:15 p.m. On April 14, 2025, Patty Braden, the Romulus Library Director, will be presenting the library's portion of the budget. Also included is the FY25/26 Preliminary budget that was provided by the 34th District Court. City Department Heads will be present on April 28, 2025, a study session to answer questions related to their respective budgets and/or department operations.

The public hearing is scheduled for May 12, 2025, at 6:30 p.m. with official adoption and tax levy authorization on May 27th, 2025, at the regular Council meeting. The FY25/26 Budget becomes effective July 1, 2025.
