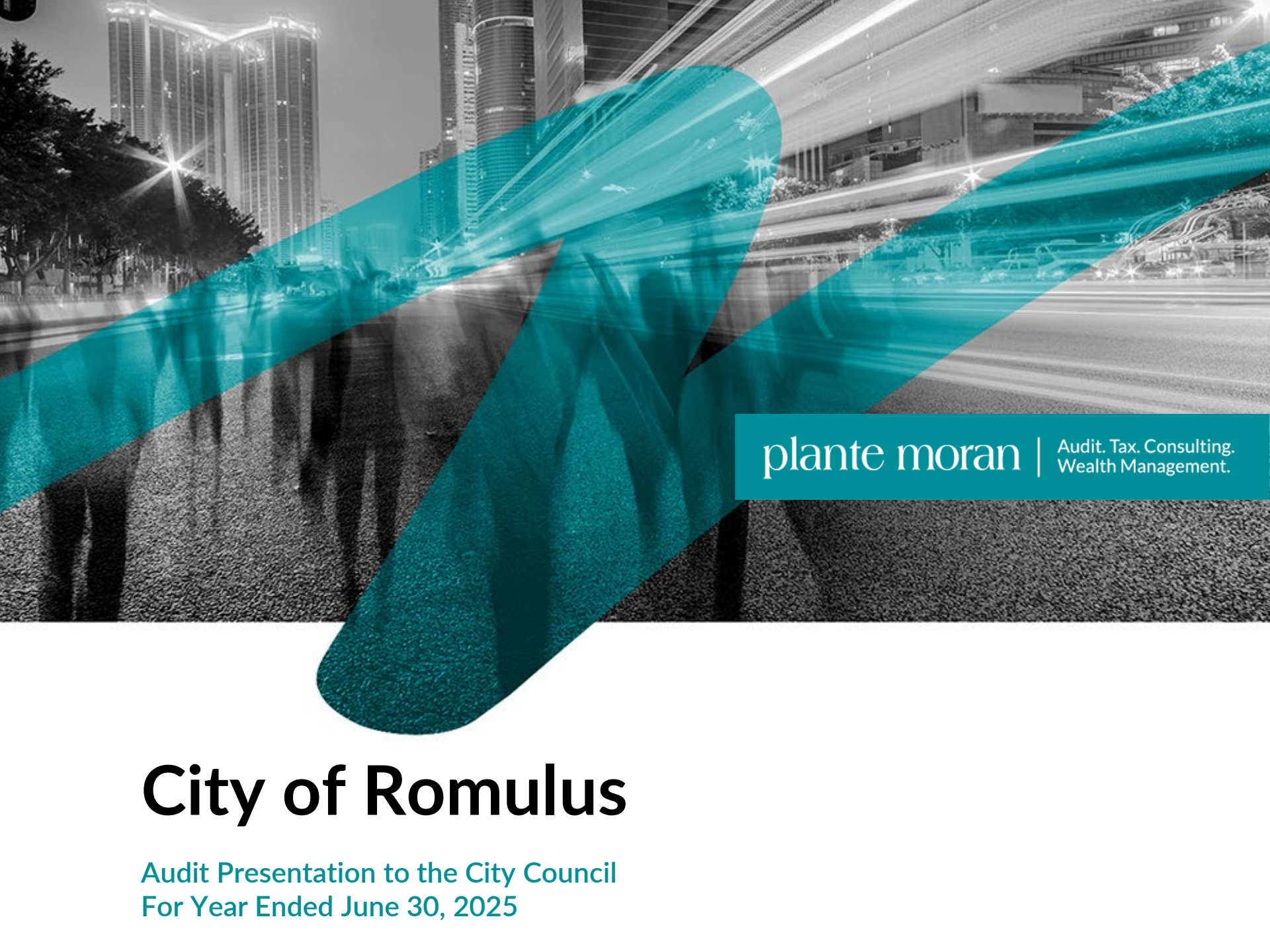

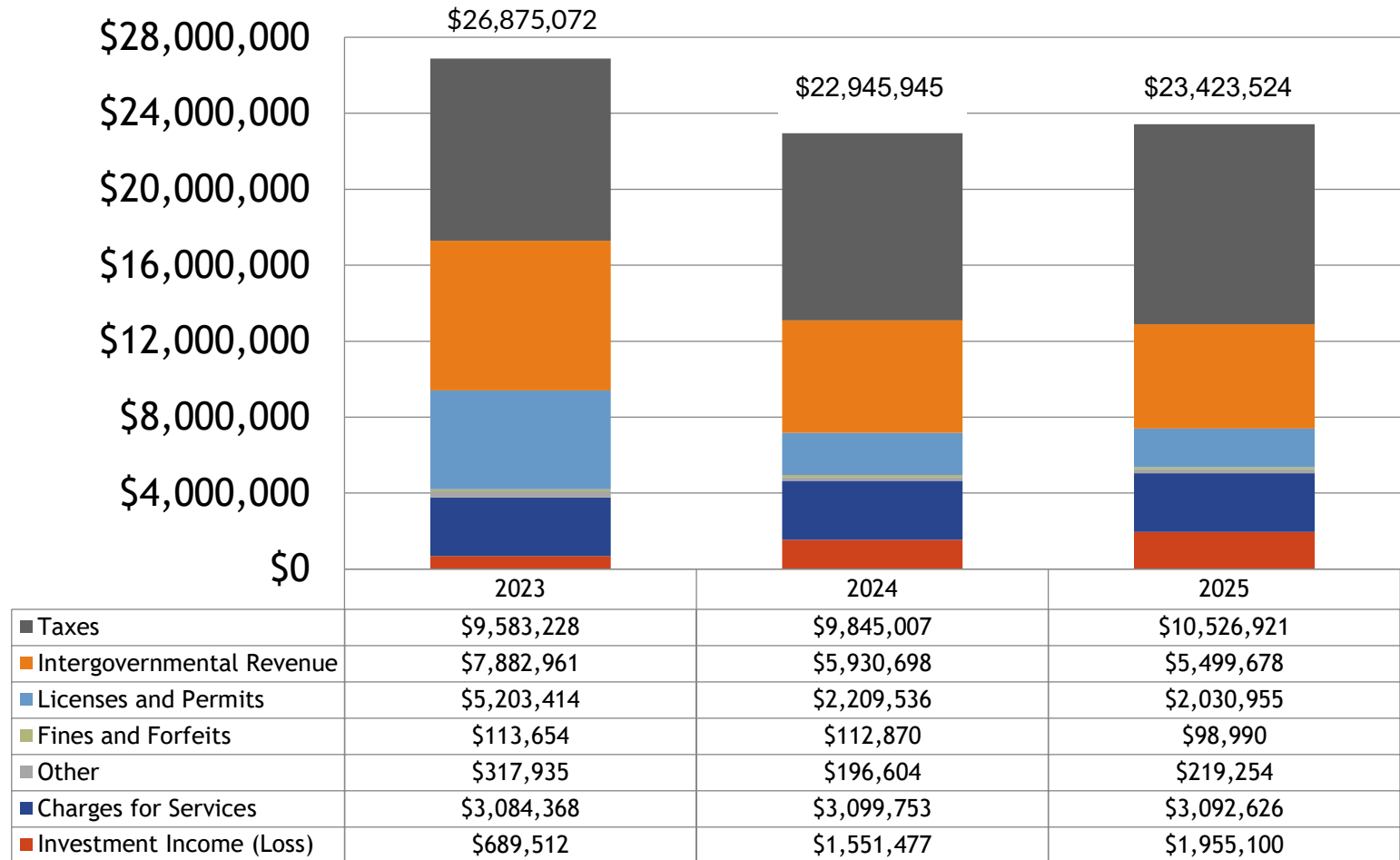
Audit Presentation to the City Council

Years Ended June 30

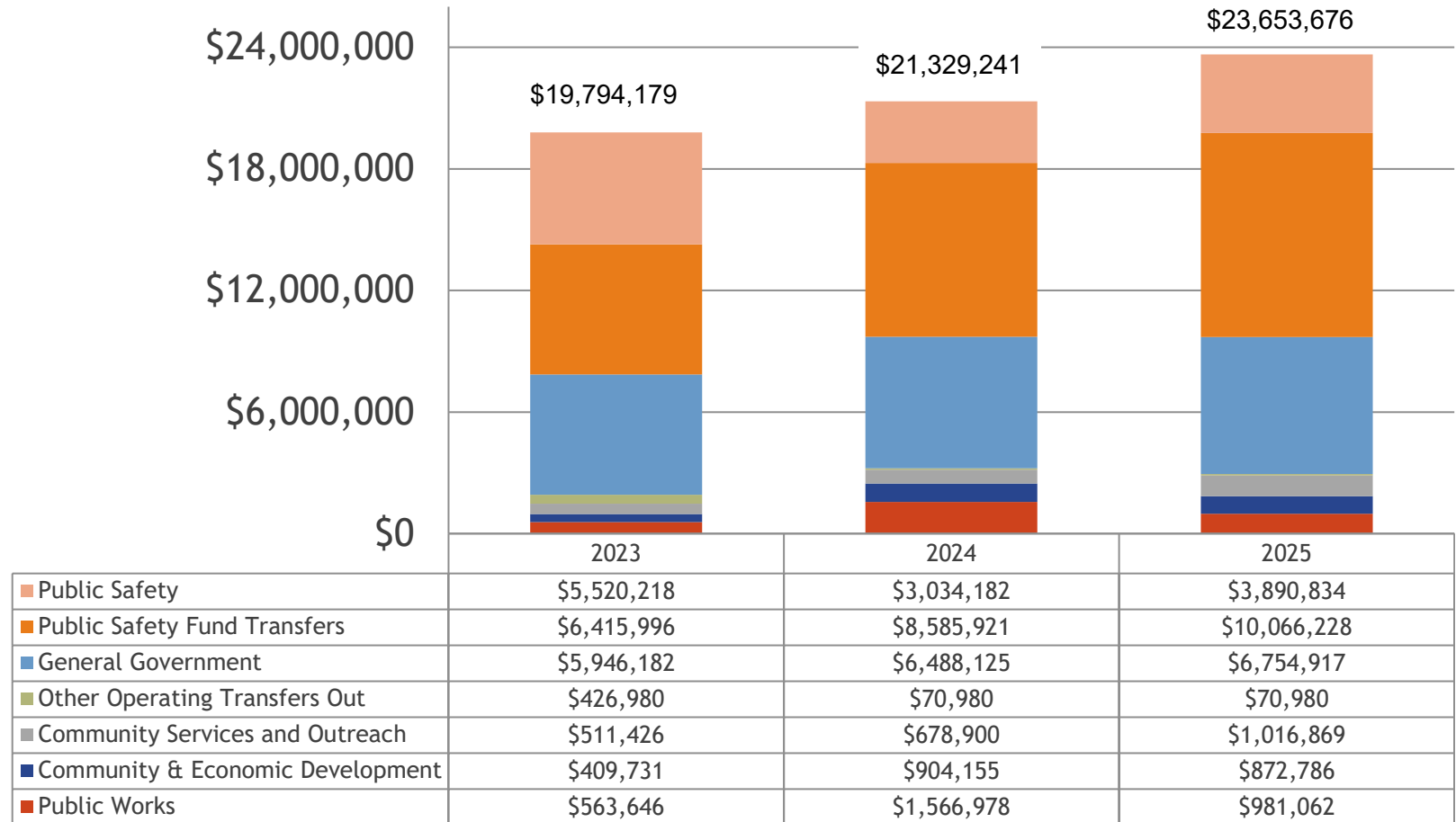

Years Ended June 30

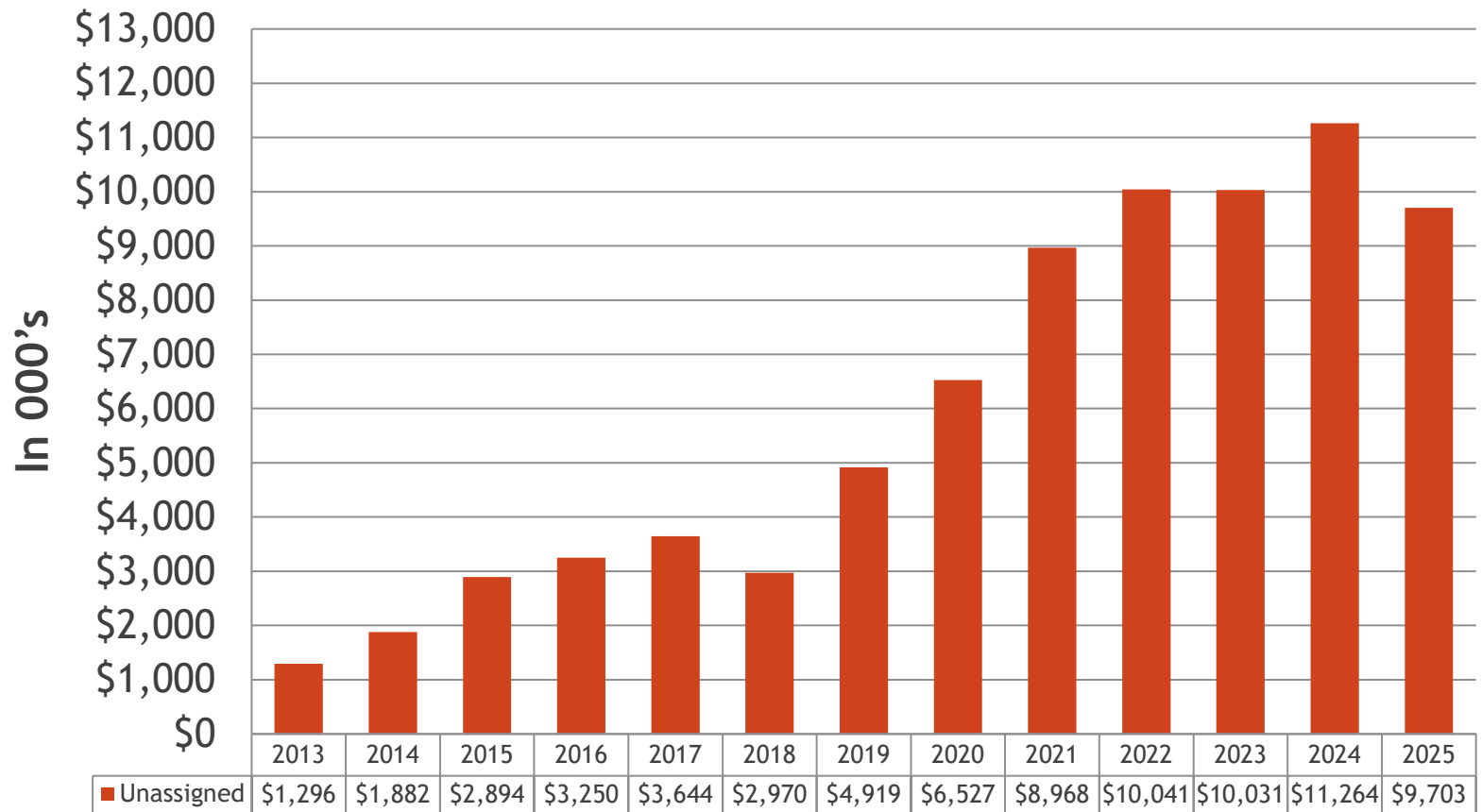

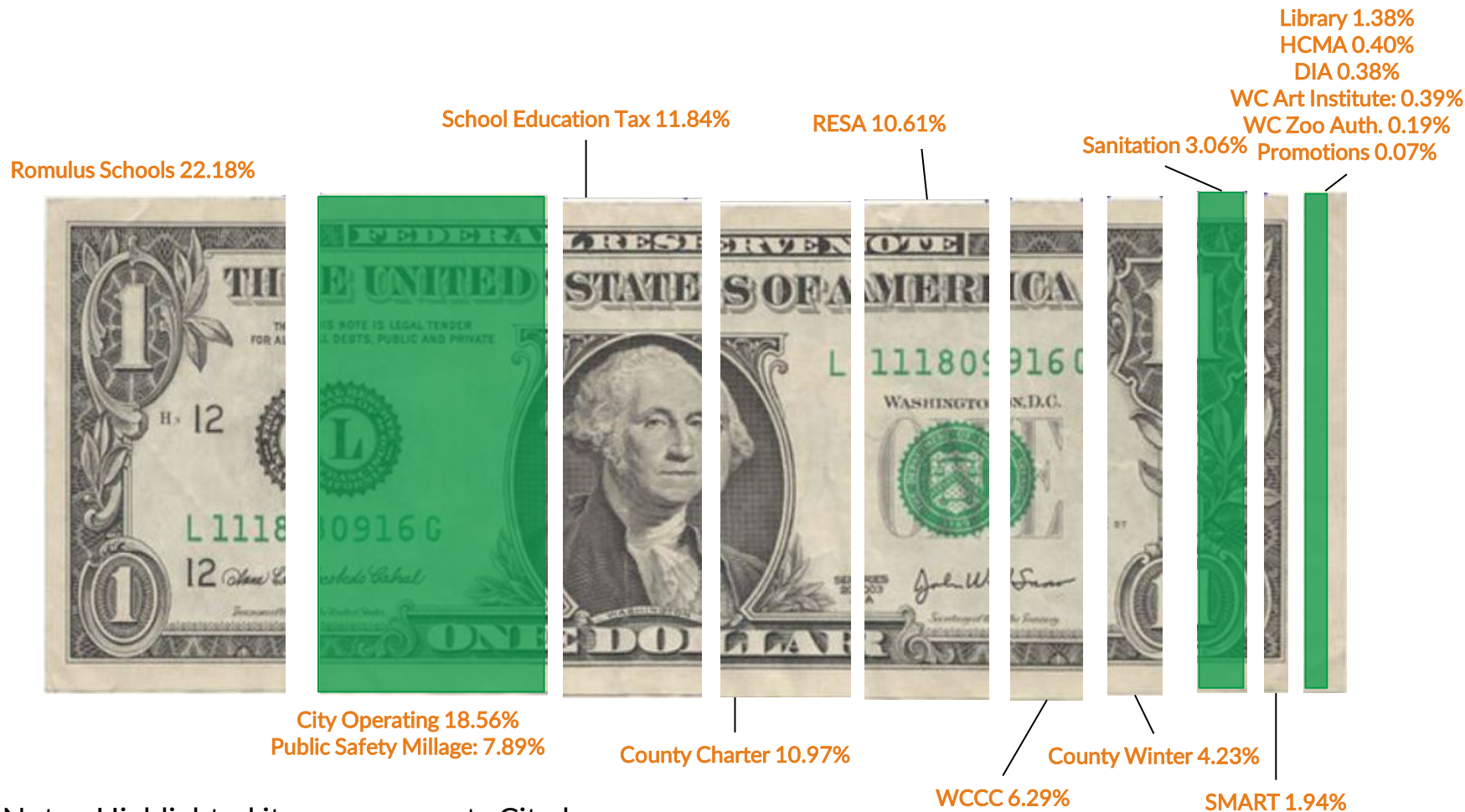
General Fund – Unassigned Fund Balance

Note: Highlighted items represents City levy

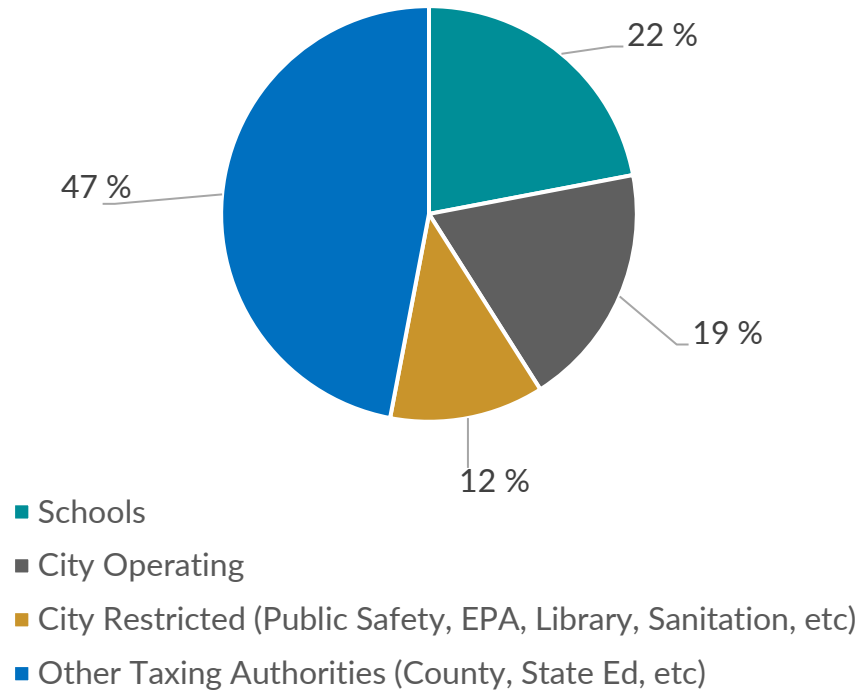


For every dollar collected by the City, only **31 cents** goes to the City for Municipal Operations, the rest go to other taxing authorities.



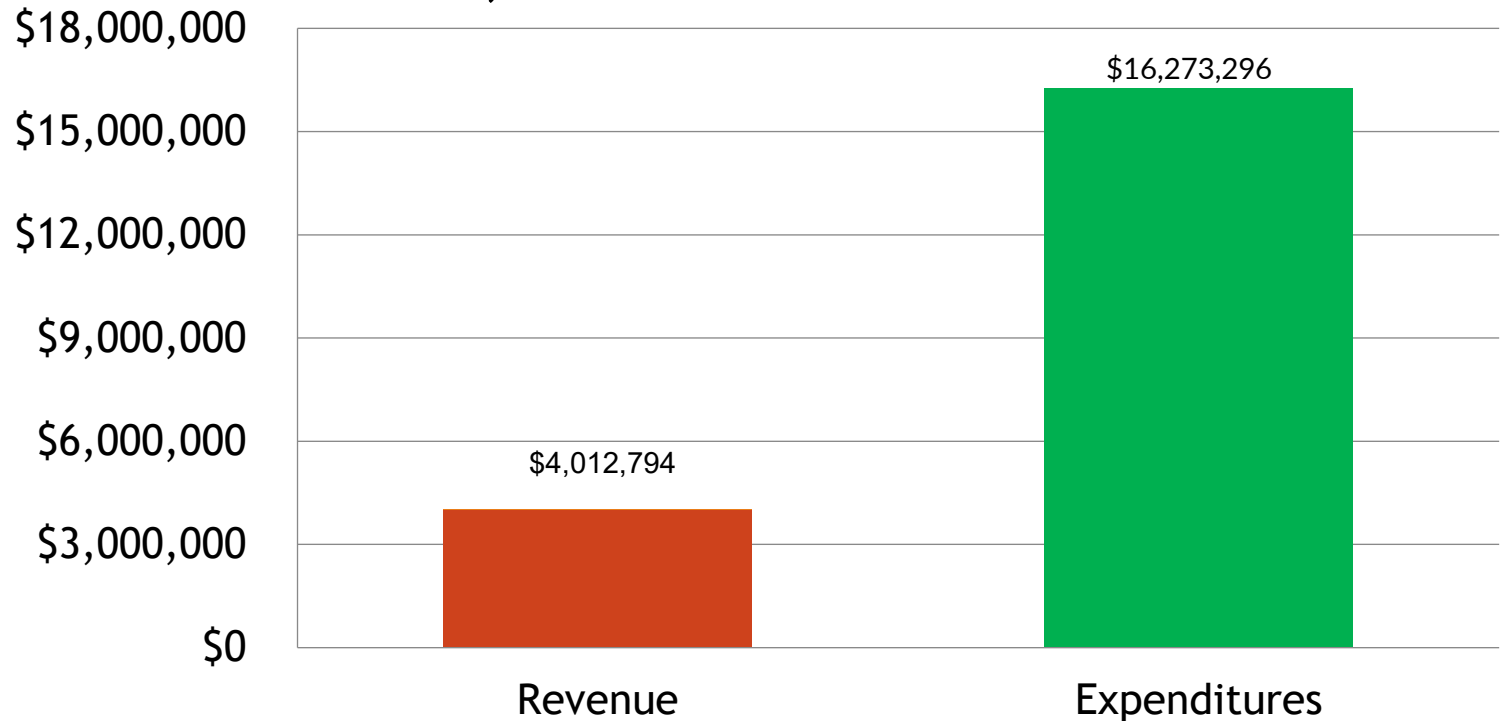
City of Romulus Property Tax Collection Allocation

City of Romulus Public Safety Fund Property Tax Revenue and Expenditures Year Ended June 30, 2025

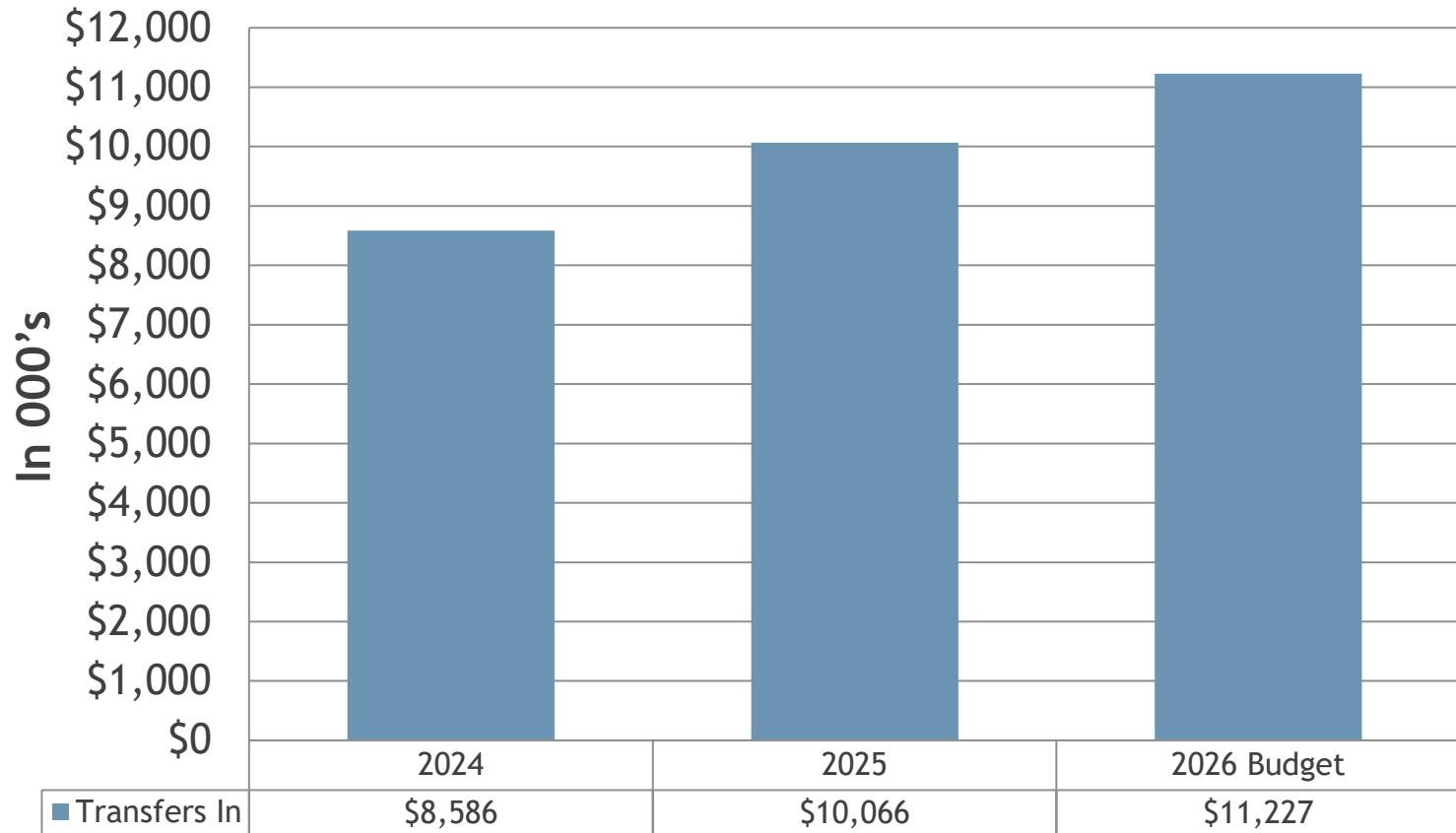


Note: The General Fund transferred \$10,066,228 to the Public Safety Fund to cover public safety expenditures not funded through the millage for the year ended June 30, 2025.

Of the \$16.3 million expenditures noted above, the police department represents \$11.2 million and the fire department represents \$5.1 million.

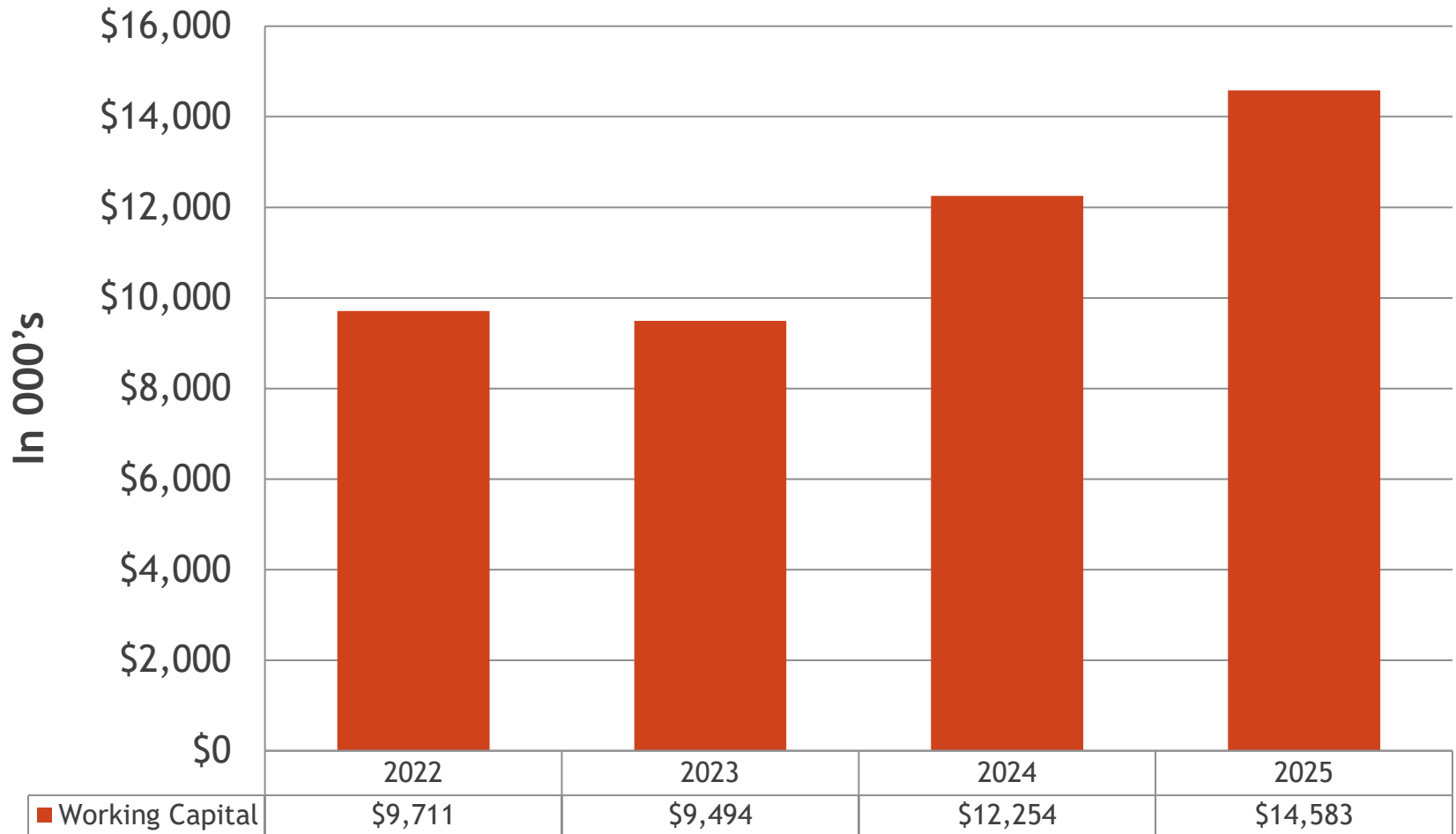


Public Safety Fund Transfer From General Fund





City of Romulus Water & Sewer System Years Ended June 30

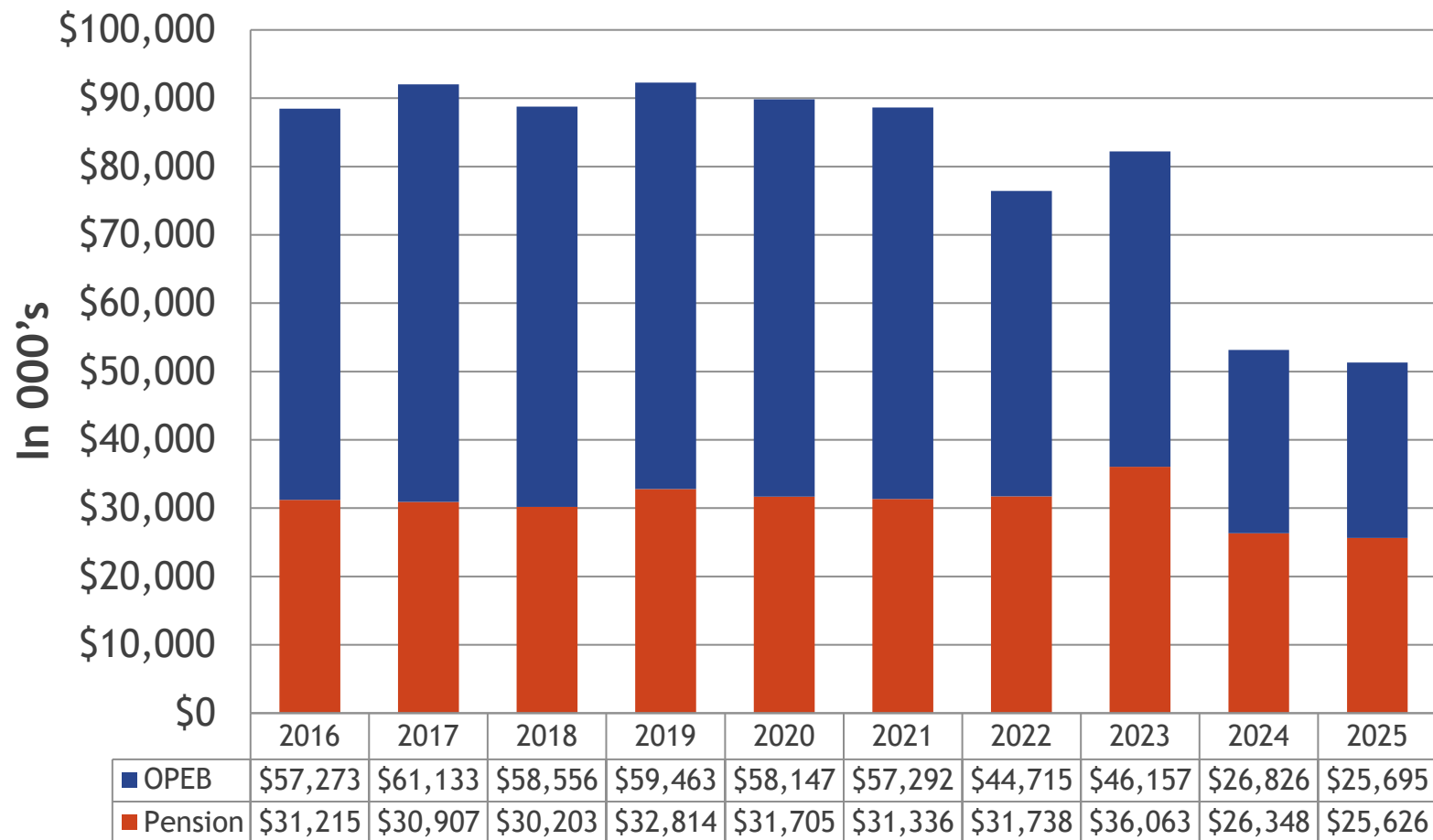
